Criteria

Preliminary Short Listing

- Governance structure
- Accreditation/ Quality certification
- Responsible business activities
- Paid services
- Financial support availed from Schemes of Government of India or State Government
- Financial support availed from National/International Organizations/Companies
- Nature and effectiveness of the Responsible Business Activity proposed for the Award
- Degree of Innovativeness of the Responsible Business Activity
- Any other criteria as suggested or amended by Jury.

Final Short Listing

- 40% weightage to the marks obtained in preliminary shortlisting.
- 60% weightage to the marks obtained in case-study based on the following criteria:
 - Fund mobilization
 - Outreach of benefits to member, non-member community
 - Sustainability
 - Support documents
- Any other criteria as suggested or amended by Jury.

- National/State/Regional level

2. BMOs registered as:

- Society
- Trust
- Co-operative society
- Section 8 (earlier section25)/ Producers company/Company
- Any other legal entity

Assessment Process and Methodology

Stage 1:

Preliminary Application Form

Stage 2:

Preliminary shortlisting of BMOs (a maximum of 26 BMOs will be short-listed)

Stage 3:

Final shortlisting of BMOs (a maximum of 16 BMOs will be short-listed)

Stage 4:

Final selection of Awardees based on presentation by the final short-listed BMOs

Stage 5:

Award Distribution at Award Ceremony
